1. INTERPRETATION AND DEFINITIONS:



### 6 LEGAL COSTS:

IF AS A RESULT ON ANY BREACH BY THE DEBTOR OF ANY OF THE TERMS OF THIS AGREEMENT, THE SHERIFF INSTRUCTS HIS ATTORNEYS TO MAKE DEMAND OR INSTITUTE LEGAL PROCEEDINGS AGAINST THE DEBTOR, THE DEBTOR SHALL BE LIABLE FOR AND SHALL PAY ON DEMAND ALL LEGALCOSTS AND DISBURSMENTS SO INCURRED, INCLUDING ANY LETTER OF DEMAND, TRACING AGENTS FEES AND COLLECTION COMMISSION ON THE SCALE AS BETWEEN ATTORNEY AND OWN CLIENT.
