**E Execution** - Sale in execution - Immovable property - Cancellation of sale - Sheriff seeking cancellation on formal application, rather than on report to judge in chambers, as contemplated in rule 46(11)(a) of Uniform Rules - Costs - Formal application unnecessary - Judge not empowered to award F sheriff's costs - Uniform Rules of Court, rule 46(11).

Under rule 46(11) of the Uniform Rules of Court, the sheriff of the High Court made formal application in the High Court for: (1) cancellation of a sale in execution (rule 46(11)(a)); (2) an order directing that the purchaser was H liable for the loss sustained by reason of her default, which loss could be recovered from the purchaser by the applicant (rule 46(11)(b)); and (3) his costs of the application.

*Held*, in respect of costs, that the fact that applicant in the present matter had not followed the procedure contemplated in rule 46(11) did not disentitle him I to an order cancelling the sale, but it was relevant to the prayer for costs. That prayer could not be granted. Not only was a formal application unnecessary on a reading of the rule itself, but there was nothing in rule 46(11) that empowered a judge, when cancelling a sale, to make such an order. The reason for the rule's silence in that respect was that it did not contemplate a formal application, but merely a relatively terse report from J the sheriff, together with a request that the judge cancel the sale summarily.
